

End User License Agreement

This end user license agreement (the "Agreement") should be read by you (the "User" or "you") in its entirety before your use of services or products provided on the website www.Blastcrash.xyz (the "Website"). - ❖ **Desarrollos Crigame S.A.** reserves the right to update or modify this Agreement or any part thereof at any time without notice, and you will be bound by such amended Agreement within 14 days of it being posted on the Website.
- ❖ The Website is intended for the User's private personal use. Please note that the Website is not for use by (i) individuals under 21 years of age, (ii) individuals under the legal age of majority in their jurisdiction, and (iii) individuals connecting to the Website from jurisdictions where it is illegal to do so. **Desarrollos Crigame S.A.** cannot verify the legality of the Service in every jurisdiction, and it is the User's responsibility to ensure that their use of the Service is lawful.

- ❖ You must enter all mandatory information requested into your registration form, including a valid email address. If you do not provide a valid email address, we cannot help you recover any "forgotten passwords." You are responsible for ensuring that the information you provide is accurate, complete, and correct.
- ❖ The User is obliged to keep their login credentials secret and confidential at all times and to make all efforts to protect their secrecy and confidentiality. Any unauthorized use of the login credentials shall be the sole responsibility of the User, and the User shall bear any liability therefrom.
- ❖ **Desarrollos Crigame S.A.** reserves the right to refuse to register an Account or close your Account.
- ❖ You are not allowed to play if you are a player from Costa Rica or the United States.

- ❖ Significant withdrawal requests are processed manually from a cold wallet and can take up to 24 hours.
- ❖ A small fee will be deducted from the withdrawn amount to cover blockchain transaction fees.

ACCOUNT TERMINATION

- ❖ The Website reserves the right to close your Account and refund to you the "Account balance," subject to the deduction of relevant withdrawal charges, at its absolute discretion and without any obligation to state a reason or give prior notice.

PRIVACY POLICY

- ❖ You hereby acknowledge and accept that the Website must collect your IP Address and browser information to prevent abuse of the services provided.
- ❖ **Desarrollos Crigame S.A.** recognizes that we are bound by Data Protection legislation when collecting your personal data.

APPLICABLE LAW AND JURISDICTION
